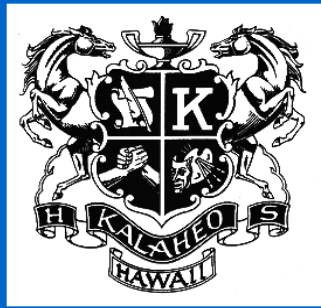

# Faculty and Staff: Retirements and Other Updates

**K**alaheo will bid fond *Alohas* to two retiring faculty members. Together, they have taught sixty-six years on the Mainland and in the public schools of Hawaii.

English teacher **Fred Cadieux**, a native of New Bedford, Massachusetts, received his BA in Social Studies, History and English from Boston University and his MA in History from Loyola Marymount. He taught 26 years in the Compton Unified School District (Los Angeles) and arrived in Hawaii in 1990. He taught at Kaiser High School for a year, transferring to Kalaheo in 1991. Fred recalls the culture shock he experienced upon arrival in Hawaii, and he quickly adapted to pidgin and other aspects of our island ways.

During his tenure at Kalaheo, many changes were observed in Fred, including his changing hair color after visits to the hair stylist. After one summer vacation, he received numerous comments from his colleagues about his new earring. Fred is an accomplished keyboard musician, a world-class traveler, and sailor. For his retirement, he is building a home in Palm Springs where he will “catch tan” and surf the Internet. His departing words of wisdom: “Stay young, stay healthy!”

Science teacher **James Redmond**, a native of Dansville, NY, received his BS in General Science from the University of Buffalo and his MA in Education from Pepperdine.

Jim taught for three years in Buffalo, NY, and then moved to Hawaii where he taught for 13 years at the Hawaii Youth Correctional Facility. He has been at Kalaheo since 1990 where he has taught science and coached wrestling, football, and cross-country.

Jim is a jazz aficionado, plays a mean trombone, and never misses the annual Sacramento Jazz Festival. He notes a memorable moment in his educational career: “I experienced educational enlightenment at the Hawaii Youth Correctional Facility!” On a more serious and positive note, Jim has enjoyed encouraging students to enter the International Bridge Building Competition.
