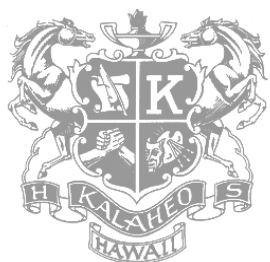

# Foundation News and Annual Report

## School Highlights 2003-2004

as reported in the *Kalaheo High School Newsletter* and *Ka Leo O Kalaheo*

Whether you are a Kalaheo graduate, parent, community member or supporter, please enjoy this brief look at last school year. Gleaned from monthly school newsletters and student newspapers, here's a sampling of the school's varied activities and outstanding accomplishments.

### August

Student leaders attend summer events where they learn to plan and improve student government activities.

Ten teachers attend a summer International Advanced Placement Institute at Kapiolani Community College.

Kalaheo welcomes 15 new teachers.

The first day of the school year is New Student Orientation Day. Freshmen and other new students attend morning events to meet new people, play games, tour the school and sign up for activities.

Kalaheo begins its 31st year of athletic competition, fielding 51 teams in 17 sports.

### September

A new school P.R.I.D.E. program encourages positive attitude, respect, integrity, discipline and excellence.

With fifty percent more cadets than last school year, NJROTC expands in size from battalion to company; the company conducts a flag ceremony once a week at 7:45 am. in front of H-Building.

The PTSA and PCNC organize activities for Make-a-Difference Day when parents, students and staff members work to improve the campus.

Two fundraisers are announced: Christmas tree and *Entertainment Book* sales.

A Communications Academy is launched, thereby aligning a portion of the curriculum with the national high school reform movement.

Students continue traditional complaints about school lunches, except for kalua pig days when even alumni are spotted in

the too-long lunch lines.

Mandatory Senior paper projects will be written on environmental issues.

### October

Homecoming activities include dress up days, lunchtime activities, building decorations, a dance, a motorcade and the big game.

Alumni Homecoming Week Dinner is held at Kaneohe Yacht Club.

Students are required to wear school ID badges during the school day and at school-sponsored events.

Eight Communications Academy students pick up 12 awards at the International student Media Festival in Anaheim, CA.

### November

The College-Career Center continues to announce SAT prep classes, test dates, financial aid nights, special programs, and a monthly lists of college speakers.

Parents continue to gear up for Project Graduation 2004.

### December

Kalaheo's first Special Olympics team prepares to participate in singles bowling and track and field. Six "Holiday Classic" bowling participants receive gold, silver and bronze metals.

AP/Honors teachers seek qualified students for next year's Grade 9-11 Honors classes in English, social studies, math and science, and Advanced Placement courses in Literature, Language, American History, European History, Biology, and Calculus.

Food Services students apply their cooking and presentation skills to creating Spam Benedict, Smoky Cheddar Potatoes with Spam, Spam Vegetable Lumpia, Spam Hawaiian Pockets and more. (The Food Services teacher retires, a decision unrelated to the Spam Cookoff!)

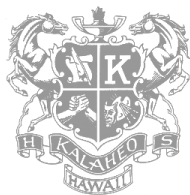

### January/February

“History Day at Night” features National History Day projects by junior social studies students. Documentaries, project boards, theatrical performances and papers are displayed throughout the library for viewing by the Kalaheo community.

The librarian announces an increasing number of online subscription databases with both school and remote access for teachers, students and their families.

### March

ASK leads celebration of Drug Free Week with a Valentine’s theme.

Freshman/Sophomore Party is held at the Koolau Golf Club Ballroom.

First semester Honor Roll students (3.5+ gpa) are receive certificates and cake and ice cream treats.

The “Second-Hand Drive” collects clothing and other items for St. Anthony Parish Outreach.

### April

A team of educators representing the Western Association of Schools and Colleges (WASC) were positively impressed when they spent four days on campus prior to recommending a term of accreditation. (Based on the school’s *Accreditation Report* and the visitation, Kalaheo subsequently received a six-year term.)

Six students win at the Windward District Science Fair, including a first place winner invited to participate in both the State and International Competition.

The Hawaii Academy of Science recognizes three Kalaheo students for their award-winning science projects.

The Sixth Annual PTSA Silent Auction and Wine Tasting fundraiser at Koolau Golf Club is another huge success. The event supports the PTSA scholarship and enrichment fund.

Senior Prom is held at the Hilton Hawaiian Village Tapa Ballrooms in Waikiki.

Junior Language Arts class celebrate American literary tradition with an “American Writers” evening event in the Kalaheo library.

### May/June

Students perform scenes and recite soliloquies and sonnets at the Shakespeare Festival, an evening event sponsored by the Language Arts Department.

Four students perform in “Bye Bye Birdie!” at Castle High School’s Bright Theater.

Four Special Olympics students take first place in Windward District track and field events.

Kalaheo celebrates Multicultural Month, this year featuring Portuguese, Italian, and Tahitian. Activities included a spaghetti eating contest and lei-making.

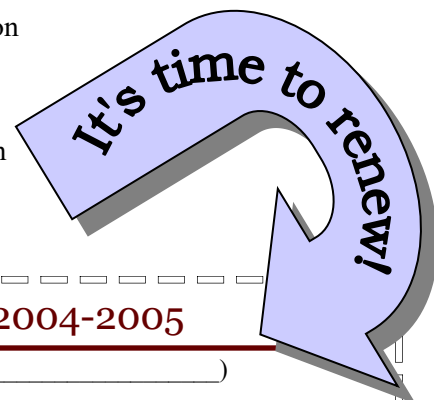
