Foundation president sets agenda

When I was approached about being nominated for the Kalaheo Foundation presidency, I had to ask myself: “What is it that I can contribute to the organization?” After thinking about it for a few weeks, I decided my primary focus would be to increase membership and participation of alumni.

To accomplish this goal, I realized that the first thing I needed to do was improve our Web site. Therefore, during Summer 2005, the site which I started way back in the early 90s was redesigned. New features include the ability to have annual membership dues and donations automatically renewed via PayPal. Alumni database searching has been improved, and a “comments” section added so alums can let others know what they’ve been up to.

A second project is the State of Hawaii vehicle license plate program which allows anyone who supports the Foundation to purchase a special license plate bearing the Kalaheo High School coat-of-arms. (See page 6 for details.)

The final project is related to the Christine Snyder Memorial on the Kalaheo cam-

pus. (See page 5.) A graduate of the class of 1987, Christine was a victim on United Flight 93 that crashed in a Pennsylvania field on September 11, 2001. In her memory, students and alumni planted a golden shower tree in front of A-Building.

Currently, no marker identifies this memorial. The Foundation plans to dedicate a plaque on September 11, 2006, the fifth anniversary of that tragic day. 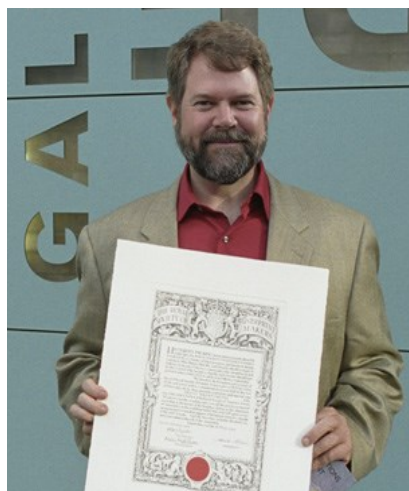
Featured Alumnus: David Smith, Class of 1980

Kalaheo alumnus David B. Smith, Class of 1980, was inducted into England’s prestigious Royal Society of Painter/Printmakers in a ceremony held in London on May 22, 2005. David is the first Hawaii-born artist elected to the society founded by Royal Charter in 1880. After a rigorous selection process which included nomination by society members and a stringent portfolio review, David was awarded the title of Associate Royal Etcher.

David works with the Hawaii Department of Education’s Teleschool Division as Television

Production Technician and Graphic Artist. Additionally, he is a printmaking instructor at Honolulu’s Academy Art Center where he has happily taught since 1996. He is also on the Board of Directors for the Honolulu Printmakers, one of Hawaii’s oldest art organizations.

Given Hawaii’s isolated location, David notes the impressive achievements in the arts by people in Hawaii. “When we compare ourselves to our colleagues in the national scene, we sometimes feel a bit backwards but, in actuality, we match our peers on the

mainland.”

Recognizing that individuals don’t achieve these honors by themselves, he acknowledges a support system which includes the Honolulu Printmakers, the Honolulu Academy of Arts, the Hawaii State Foundation on Culture and the Arts as well as local Hawaii businesses and companies.

Over the 25 years since he left Kalaheo, David has focused on study and art. After completing his core requirements during two years at Windward Community College—an experience he highly recommends because of smaller classes and more individualized instruction—he transferred in 1983 to the University of Hawaii at Manoa where he studied print-

making, specifically lithography. In this process, a thick slab of limestone is ground to a clear and level surface, drawn on with a grease crayon, and processed with Gum Arabic and nitric acid to set the image into the stone.

After the image is cured, it is rolled with ink and printed onto paper through a Litho press. “Not a smart boy!” David confesses, “I started this art form after back surgery in 1982.”

David received his Bachelor’s in Fine Art Printmaking in 1987 from UH, Manoa. In 1989, he was accepted for graduate studies at The Slade School of

Fine Art, University College, London, studying under Master Lithographer Stanley Jones, printer for such notable artists as Picasso, Braque, Manray, Moore and HRH Prince Charles of the UK.

One of the most impressive things he learned from Stanley had nothing to do with art. “Here you have a man whom the entire London art world bowed before, yet he treated everyone, from a lowly undergrad to the head of the British Museum’s Print Collection exactly the same—with kindness and respect. That is the mark of a great man!”

Following graduate studies at Slade, David received his Higher Diploma in Fine Art, the British equivalent at the time of an American Master’s degree, and went on for a further year of

extended research in photographic processing in Printmaking.

As for his Kalaheo days, David thinks that “in many ways, we establish our interests, goals and work ethic during high school and soon after.” While at WCC, he worked as a dishwasher-cook-bartender at Kailua’s former Ole’ Mexican Restaurant, so he knows what he’s talking about when he advises, “If students have talents, interests or hobbies that become passions, I think it is important for them to follow those interests, to work hard and enjoy the true professions they have in their hearts, no

matter what they have to do for a living to pay for the dreams.”

David has received the following awards: Honolulu Printmakers 70th Annual Exhibition Gift Print Artist, 1998; Persis Collection Award, 1995; The Joseph Webb Commemorative Fund Award, Royal Society of Painter Printmakers, London, 1992; Screen Printing Association International Award of Excellence in Mixed Media, 1988.

Living in Kailua and working primarily in stone and photographic plate lithography, David prints his work at the Honolulu Printmakers Workshop in Hawaii and Artichoke Print Workshop in London, an open access print studio. His art is included in the collections of The Hawaii State Foundation on Culture and the Arts Permanent Collection; The Honolulu Academy of Arts, Hawaii; The Contemporary Museum, Hawaii; and University College, London. His work has been exhibited in Honolulu, California, Kansas, South Carolina, London, Portugal, and Australia.

Kalaheo receives Small Learning Communities (SLC) grant

In partnership with Kahuku and King Kekaulike High Schools, Kalaheo received a portion of a \$2.4 million USDOE grant to create smaller learning communities during the next five years.

Starting in 2006-2007, Kalaheo's ninth graders will be scheduled into two "houses" of approximately 150 students each. Language Arts, Social Studies and Science will be grouped together.

The following year, 10th through 12th graders will be able to select academic "majors" or career pathways in order to better direct them toward achieving future goals.

Becky Kam-Locascio is the school's grant coordinator, and Jaime Suehiro is the site coordinator. Teachers on the SLC transition team are Sarah Razee, Jaysen Agena, Jessica Baguchinsky, Peter Brossy, Clara Olds, Mary Kate Powers, Kathy Shigemura, Luci Suliafu and Nicole Tomas.

SLCs promote a personalized school environment; rigorous, project-based curriculum; career pathways and academies; interventions for struggling students; more professional development for teachers; and stronger connections with parents and the community.

School Highlights 2004-2005

August '04—Freshman and other students participate in an Olympic-themed new student orientation. Kalaheo welcomes new teachers in art, career and technical education, English, math, ROTC, science and social studies. Beginning its 32nd year of athletic competition, students are encouraged to get involved in 51 teams in 17 sports.

September '04—Advisory periods are instituted to provide adult mentors to small groups of students. Special events include Military Academies Night, Senior College Night and Leadership Camp conducted for elementary students by Kalaheo's student leaders. Kalaheo receives a full six-year term of accreditation from the Western Association of Schools and Colleges (WASC).

October '04—Homecoming events include the Kick-Off Spaghetti Dinner, daily special events and the big game against Radford. Study hall for student athletes is initiated. Lewis Fuddy, long time Kalaheo teacher, is named new athletic director, succeeding a happily retired Lee Cashman. Communications Academy students travel to New York to pick up 10 national awards won at the International Student Media Festival.

November '04—The National Honor Society sponsors the first of its biannual blood drives in the Kalaheo Library. Signs in French, student newscasters wearing berets, banners and a sidewalk café herald National French Week. Many students participate in Challenge Day, an award winning program designed to tear down walls and inspire students to live, study and work in an environment of compassion, acceptance and respect. NJROTC's Special Operations Team participates at Schofield Barracks in an overnight "Navy Team Challenge," winning a majority of the awards and First Place Overall.

December '04—Faculty reads final Senior Papers. The Music Department presents its Winter Concert with performances by the concert band, choir and jazz ensemble.

January '05—The Science Department hosts Kalaheo's Science Fair with 12 students receiving first place honors and advancing to Windward District competition. Business Education students launch the First Annual Kalaheo Business Plan Expo.

February '05—The second Challenge Day inspires many more students. During Drug Free Week, over 150 students pledge to take control and make smart choices.

March '05—In the Kalaheo Library, about 150 ninth

graders and their teachers host State Representative Cynthia Thielen's annual Legislative Roadshow, an interactive program which asks students to research current legislation and participate with Rep. Thielen in a mock committee hearing where students present written and oral testimony. "Students and teachers entered into this debate with enthusiasm, resourcefulness and a good deal of critical thinking," said Thielen. Later in the month, electronics students participate in the Electronic Car Marathon at Ford Island.

April '05—The PTSA's annual Silent Auction and Wine Tasting raises funds for scholarships, school improvement projects and other events. It was "Midnight at the Oasis" for the Junior-Senior Prom at Dole Cannery Ballrooms.

May '05—Expository Writing students revive Kalaheo's long-absent literary magazine, publishing poems, short stories, essays and art by students, teachers and parents.

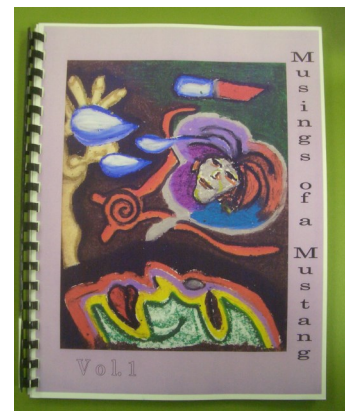
